#### ***Message from the Principal:***

Based on the numerous indicators that measure the quality of education, Coweta Intermediate High School is one of the best in the state of Oklahoma. The Education Oversight Board/Office of Accountability has challenged schools to score at least 70% in each subject area of the Core Curriculum Tests. Coweta Intermediate students exceeded this goal in both Algebra I and Geometry End-of-Instruction tests. Despite this good news, we are not satisfied. There are a number of areas that we are targeting in the upcoming years for improvement. Rest assured, our goal at CIHS is for continued improvement and growth in educating all of our students.

One of our major focus areas will be to get our students ready for the Algebra I and Geometry End-of-Instruction tests. Beginning with the class of 2012, students must pass Algebra I and three of six others to meet the requirements for graduation. This high stakes testing signals the beginning of a challenging time in education.

We have identified a number of goals that will assist us in preparing our students for the challenges that lie ahead. One of the first and easiest goals will be to improve attendance. It is a simple fact that your children cannot learn if they are not in class. Students will miss classes throughout the year for a wide range of activities and events, but please make sure they are here as many days as possible. Secondly, please make sure that your family sets a high priority on learning in your homes by setting times to study, asking about grades, and attending parent-teacher conferences. We have a student information system in place which will allow you to view your student's grades, attendance, and homework. Please take advantage of the parent portal and our website.

While we are proud of this report card, we realize we must continue to improve. We take great pride in educating your children and we constantly strive to do it better. We do need your help and together we can raise successful citizens and lifelong learners.

Citizens of Oklahoma:

Through these School Report Cards, the Education Oversight Board and the Office of Accountability have brought to parents and patrons measures of public school performance. The Education Oversight Board's own "70% Performance Benchmark" challenges schools to have at least 70% of their "regular full academic year" students scoring Satisfactory or Advanced in each subject area of the Oklahoma Core Curriculum Test. Schools have worked very hard to meet this challenge.

The Education Oversight Board also recognizes schools that have met an even greater challenge. A star denotes grade level performance where schools, in addition to meeting the "70% Performance Benchmark," have gone above and beyond to have at least 25% of their students scoring at the Advanced performance level in every subject area being tested.

A wealth of other information is included on this report card. The Community Characteristics section describes the socioeconomics of the community being served. The Educational Process section presents statistics on how education is being delivered to students. The final section provides data on student performance in the local public schools, in the regional Career-Techs, and in Oklahoma's institutions of higher education.

As a stakeholder, we urge you to weigh the information provided on this card and determine for yourself the quality of the education being delivered to students. Compare your school's report card with that of other schools by going to our web site (shown below). Where your school is strong, acknowledge their good work. Where your school is weak, work with staff to improve it. Become a partner with education and get involved.

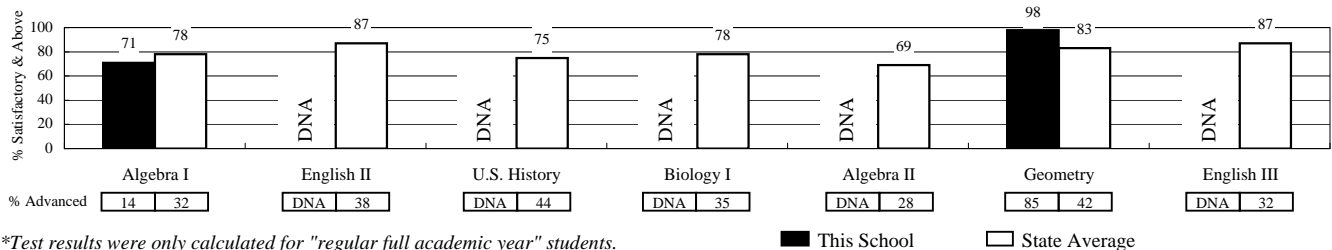
